Job Summary:

The RECE will provide a high quality program of education and care for children in a group setting under the direction of the Program Supervisor reflecting the principles of Early Learning for Every Child Today and Ontario's Pedagogy for the early years, How Does Learning Happen?, and in accordance with the regulations of the Child Care and Early Years Act. They will collaborate in the planning, implementation, and evaluation of a developmentally appropriate program that facilitate learning and the attainment of the developmental goals for the children and focuses on active learning through exploration, play, and inquiry. They will participate in the supervision and the evaluation of supply staff, students, and others in the implementation of emergent curriculum/project approach. - Early Childhood Education Diploma/Degree from a recognized community college or University or other equivalent education qualifications;
- Minimum of one-year experience in a Licensed Child Care Program with the appropriate age group;
