They will collaborate in the planning, implementation, and evaluation of a developmentally appropriate program that facilitate learning and the attainment of the developmental goals for the children and focuses on active learning through exploration, play, and inquiry. They will participate in the supervision and the evaluation of supply staff, students, and others in the implementation of emergent curriculum/project approach.
